Plans may include conducting family sessions, identifying supports, and linkage to outpatient mental health/substance abuse service in effort to assist a patient in maintaining stability in their own community.

QUALIFICATIONS: Requires a BA/BS in a human services field from an accredited university or college. One year of experience in the behavioral health field. ***INPATIENT PSYCHIATRIST (FT Preferred)**
