**QUALIFICATIONS:** Requires a BA/BS in a human services field from an accredited university or college. One year of experience in the behavioral health field. ### **\*INPATIENT PSYCHIATRIST (FT Preferred)**

They perform medication management, provide consultation, second opinions, and appear in mental health hearings as needed.
